Notice, based on the reports generated from the e-voting system provided by Central Depository Services (India) Limited (CDSL), the agency engaged by the Company to provide e-voting facility and poll conducted at AGM, in a fair and transparent manner.

As per the confirmation received from the Company:

- 3. The Company has completed the dispatch of Notice of the 105<sup>th</sup> AGM dated 14<sup>th</sup> May, 2018, along with statement setting out material facts pursuant to Section 102 of the Companies Act, 2013 by 9<sup>th</sup> July, 2018, to its members through email whose email id is registered with the Registrar and Share Transfer Agent (RTA)/ Depositories and dispatched to other members on 7<sup>th</sup> July, 2018 through courier at their registered addresses.
- 4. The said Notice was dispatched on the basis of Register of Members made available by M/s. Freedom Registry Limited, the Registrar and Share Transfer Agent of the Company and the list of beneficial owners made available by the depositories viz. National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL).
- 5. As per Rule 20 of Companies (Management and Administration) Amendment Rules, 2015, the Company has published advertisement about completion of dispatch of Notice of meeting and providing e-voting facility in Newspapers named "The Financial Express" (English Newspaper) and "Mumbai Lakshadeep" (Marathi Newspaper) on Sunday, 08th July, 2018.
- In terms of the aforesaid Notice, voting through electronic means was kept open for 03 (Three) days from Sunday, 29<sup>th</sup> July, 2018 (10:00 am) to Tuesday, 31<sup>st</sup> July, 2018 (5:00 p.m.).
- 7. The voting rights of members was considered in proportion to their shares held in the paid up equity share capital of the Company as on the cut-off date i.e. Wednesday, 25<sup>th</sup> July, 2018.
- 8. As required under the said rules, after the closure of the voting at the AGM, the votes casted through poll papers were counted; thereafter the votes casted under e-voting facility were unblocked in the presence of CS Bhavya Gala and CS Khyati Shah, representatives of Scrutinizer who are not in employment with the Company.
- 9. The poll papers which were incomplete and/or found defective have been treated as invalid and kept separately.
