- The Company has collected around US\$ 88K (Rs.86 Lakhs) for 9 months ended 31.12.2025, from several companies towards image copyright infringement charges during FY. This is part of the other income. This is a result of legal action taken by the company against several large international media companies using izmo's automotive images illegally.
- Employee benefit expenses for the Nine months ended 31.12.2025 includes Rs.353.51 lakhs (PY same period: Rs.231.91 lakhs) expenses recognised on account of stock option offered to employees under ESOP Schemes, recognised over the vesting period.
